The meeting was started with welcome wishes for the New Year 2020 and opening remarks by Dr. I. N. Patel, Chairman, Academic Council. Dr. Patel briefed in short that all the Members of BVM Board of Governance has expressed satisfaction on overall performance in Academics, co-curriculum and extra-curriculum activities. After brief talk about various activities in the institute, Dr. Patel invited Dr. P. M. George, Dean, Academics to proceed the meeting.

Dr. George, Dean, Academics welcomed the members and invited Dr. V. J. Patel, Associate Dean, Academics & Member Secretary, Academic Council to present the Agenda items:

AC.1920.2.1. To approve the Minutes of Academic Council meeting AC.1920.1 held on 28.09.19. **ANNEXURE – I.**

Resolution:

The minutes was unanimously approved.

AC.1920.2.2. To approve the “**Internship Guidelines**” suggested in CDB meeting held on 08.01.2020 (Item No. CDB.1920.6.2). **ANNEXURE - II.**

Resolution:

After thorough discussion the Internship Guidelines were unanimously approved with following suggestions:

- i. Successful completion of the internship course shall be on total marks obtained by the students out of 100 marks. If, student gets less than 50 marks out of total marks (CE P and ESE P), he/she will be awarded FP letter grade, otherwise PP grade.
- ii. If student is awarded FP grade, he/she shall be re-examined only.

Corrected Internship Guidelines are attached herewith as **Annexure – II.**

AC.1920.2.3. To approve the resolution passed in CDB meeting held on 14.10.19 (Item no CDB.1920.4.2).

“Remedial mid semester examination should be conducted for students of B. Tech. - 1st Semester, D2D - 3rd Semester and M. Tech. - 1st Semester of A.Y. 2019-20 entry and onwards in respective academic year.”

Resolution:

After thorough discussion the following resolution was approved with addition of 1st Year PDDC students as below:

“Remedial mid semester examination should be conducted only for students of B. Tech. - 1st Semester, D2D - 3rd Semester and M. Tech. - 1st Semester and PDDC – 1st Semester, in the respective academic year from A.Y. 2019-20 onwards.”

AC.1920.2.4. To approve the resolution passed in CDB meeting held on 29.11.19 (Item no CDB.1920.5.6).

“It was unanimously resolved to constitute a Committee to prepare modalities of converting students curricular, co-curricular and extra-

curricular activities in to points to enhance the overall personality of students”.

Resolution:

It was unanimously resolved to constitute a Committee to prepare modalities of converting students curricular, co-curricular and extra-curricular activities in to points to enhance the overall personality of students. The committee shall comprise of following members

1. The Vice- President/s, Central Committee – Any one of them shall be appointed as Convener.
2. One member from Cultural Committee
3. One member from T&P/NPTEL/IIC.
4. One invited member

It was also further suggested that committee shall consider following suggestions made by the respected members.

- a) Dr. N. D. Jotwani has telephonically suggested that performance in co-curricular and extra-curricular activities shall not be reflected or clubbed with Academic Performance Index. He also suggested that there shall not be mandatory provisions for co-curricular and extra-curricular activities. However, the institute can promote such activities by indicating it into transcript as non-academic performance.
- b) Dr. Sudhir Kumar has suggested that the committee shall make such provisions that all students participate in such activities voluntarily.
- c) Dr. I. N. Patel has suggested that the Committee formed for the same shall finalize the rules.

“It was unanimously resolved that, if needed maximum two Months extension can be permitted for completion of Dissertation of M. Tech. Students. The extension period should be reflected in the result declaration list”.

Resolution:

After thorough discussion it was resolved that the extension for completion of Dissertation of M.Tech. student (s) shall be permitted case to case by concerned Chairman, Board of Studies and same will be presented to Dean, Academics for approval. The list of case to case extension should be presented in Academic Council.

- ii. The course content of HS112 and 3CE81 shall be evaluated to avoid the common course content.
- iii. The title of 3SE81 shall be reconsidered
- iv. The number of Open/Program Electives shall be increased

During the discussion, following suggestions were made by the members. The suggestions were appreciated by the Chairman and the council, necessary arrangements will be made for implementation of the same:

- i. Number of Unit in the course syllabus shall be uniform.
- ii. Open Electives for all the disciplines should be discussed and finalized in general - based on needs of respective Board of Studies and to avoid the similarities in the course title and syllabus.
- iii. It is advisable that the respective Board of Studies shall maintain Course Weightage as per AICTE recommendations.
- iv. Mechanism for International Experience Program (IEP) with partner overseas university to be establish, GTU guidelines can be taken as base and accordingly respective Board of Studies decide the course with appropriate mapping. Dr. P. M. George and Mrs. Dr. K. D. Patel will look for same.
- v. It is advisable that the Internship Courses (Non-credit, mandatory) and Project Courses (Credit) shall be clubbed together as per the need of respective Board.

Chair expresses sincere thanks to team Academic, Exam and all Board of Studies, ICC and members of Academic Council for constant support. He also acknowledged guidance and cooperation of Board of Governance and GTU all the time.
